DECLARATION OF DAVID CRESPI

I, David Crespi, hereby declare, under penalty of perjury, the following:

1. I am 55 years old and am incarcerated at Albemarle Correctional Institution in North Carolina. On January 20, 2006, I took the lives of my twin daughters Samantha and Tessara while under the influence of a prescribed psychotropic drug cocktail including fluoxetine, trazadone, zolpidem, and eszopiclone.


2. Before taking the aforementioned medications and the subsequent tragic deaths of my twin daughters at my own hand, I was a caring father and responsible provider for my family, with no history of violence. Prior to the tragedy visited upon our close-knit family, I was the Chief Financial Officer of Sacramento Savings Bank, and a Senior Vice President of Wachovia Bank.

3. I've had the opportunity to review the Food and Drug Administration (FDA) Adverse Event Reports ("FAERs") numbered 6048448, 6077845, 6351365, and 7102092 pertaining to my case, and in fact I was the reporter in FAER 7102092. I was surprised that

the case narratives of the aforementioned FAERs were completely redacted, and that the FDA has claimed that the redaction was to protect my personal privacy, especially since my case was widely reported in the media, and was discussed in the documentary films *The Dark Side of a Pill* and *Letters from Generation Rx*. I do not consider the information contained in the aforementioned FAERs to be private, and want the information contained therein to be fully disclosed to the public in order to warn others of the risks of homicidal ideations and homicidal actions associated with the medications I was prescribed.

5. Regrettably, the FDA did not require adequate label warnings of the homicidal risks associated with the medications I was prescribed in time to protect my twin daughters, my family, and me, and the agency is certainly not protecting the American public now by continuing to withhold reported drug adverse reaction information contained in FAERs 6048448, 6077845, 6351365, and 7102092.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct. Executed this 16th day of June, 2016.


