**DECLARATION OF KURT DANYSH**


I, Kurt Danysh, hereby declare, under penalty of perjury, the following:

1. I am 38-years-old and am incarcerated at Frackville State Correctional Institution in Pennsylvania. On April 25, 1996, at 18-years-old, I took the life of my father, Wasyel Danysh, just seventeen (17) days after being prescribed the antidepressant Prozac (fluoxetine). Since the tragedy, the Food and Drug Administration (FDA) has issued a black box label warning – the strongest possible – on Prozac of clinical worsening and unusual changes in behavior, particularly in children, adolescents, and young adults.

2. I've had the opportunity to review the FDA Adverse Event Reports ("FAERs") numbered 6328428 and 7245882 relating to my case, the case narratives of which have been completely redacted. To my surprise, the FDA has justified the redaction of the case narratives under the pretext of protecting my personal privacy, whereas the particulars of my case have been made public on the website [thesaveproject.com](http://thesaveproject.com), with my consent, and in the *pro se* lawsuit I filed against Prozac-maker Eli Lilly.

3. I do not consider the information contained in the FAERs 6328428 and 7245882 to be private, and want the information contained therein to be fully disclosed to the public in order to warn others of the homicidal risks associated with the medication I was prescribed.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct. Executed this 14 day of June, 2016.


